PLAYER CONTRACT

This agreement is entered into this _____ day of _____ 2010 for the 2010-2011 Soccer Year by and between _____ ("Player") and High Plains Drifters Soccer Club (the "Club").

Player desires to be affiliated with the Club for the soccer year and the Club agrees to accept the Player as an affiliate of the Club for the soccer year. - The Club, subject to Player and Parent complying with their respective contracts, promises to maintain Player on the Club for the duration of the soccer year and to provide Player with the same instruction and assistance as provided to other members of the Club.
- Player agrees to comply with the Rules of the Club and acknowledges receipt of a copy of this contract. A copy of Club Rules is available online.
